Mr Fletcher introduced himself to the Parish Council and explained that he had brought with him large copies of the plans and also a comment book which he could leave with the Parish Council if they wished.

Mr Fletcher provided the Parish Council with back ground planning history and what improvements have been taken into consideration; lowering the ridge height; unit 3 is detached; in keeping with the main unit. All the Councillors at the meeting had previously looked at the planning application.

Concerns were raised regarding the access, young children race down this part of the road on their scooters; this is already used for access and also when Andrew Davey repairs were carried out from this unit previously there were deliveries and cars using this regularly.

Two questions were raised

1. Does the village need 3 more houses?
2. Does this area need tidying up?

Cllr Bleaken thanked Mr Fletcher for his presentation and he could stay at the

meeting whilst it was discussed by the Parish Council. Mr Fletcher stayed to answer any questions that may arise.

The Planning application was subsequently reviewed by the Parish Council
 Cllr Robinson discussed the external materials-Mr Fletcher advised they would reuse as much of the existing material as possible, although some may be contaminated and therefore the quantity will be unknown.

The Brick work shown on the plans is already in the Conservation Area.
 It is a shame to lose natural stone can the Parish Council ensures natural stone is used, it will enhance the scene?
 The metal frame windows-the Conservation officer/planning Officer suggested these frames to be used.

It was agreed that something needs to be done with this unit in question.

Mr Fletcher explained that the preplanning application tries to look at the value of the land what is going to fit, not too much or too little. In 2007 five single units were on the application.

They have spoken to Highways regarding access.

With regards to the drive way and using bitumen a comment was raised by the Environmental department. The existing does need replacing.

The electrical substation unit is being moved concerns were raised by the electro magnetism as bedrooms will be next to it. There will be distance between the substation and the living area.

The Parish Council has no objection, it meets the smaller housing needs however there is concerns with the access, brickwork and window frames. The PC would like to see natural stone on the key walls. Also, the driveway they would like to see a sensitive treatment rather than tarmac but would not like to see pea gravel.

The aluminium window frames and cedar cladding are not in keeping with our conservation area. Use natural stone on the walls that is visible from the High Street. The bitumen driveway - please consider a more natural paving.</p>
