Mr Howard wanted to ensure that Hawkesbury Parish Council is kept up together with what is happening at "Plumbers Trench".

There have been several meetings with various organisations recently and they are waiting for South Gloucester Council to issue a report with recommendations.

It has been suggested to obtain a DMMO (Designated Map Modification Order), this will take a long time, they have held back from doing this at the moment.

It is not currently a footpath, Mr Howard advised the Councillors that previously no one had a right to go across the commons, in time it was changed for recreational use and in 1925 Right of Access on foot was given.

A question was asked to Mr Howard "if there was any commercial element" and the response was no-Mr Howard stated he had lived in Wickwar for 30 years and it is safer to ride a horse on the Commons than the roads. It was agreed that Hawkesbury Parish Council would be kept in the loop with emails to ensure we are kept up to date with the present position.

Cllr Bleaken thanked everyone for attending the Parish Council meeting and thanked Mr Howard for taking time to explain the situation.

16 The Commons

Castle Bridleways Group is a Wickwar based group aiming to improve the safety and maintenance of riding routes in Wickwar and surrounding parishes. Plumber's Trench (in Hawkesbury Parish) is part of the registered Commons and leads into Lower Woods. Currently, although some people have rights to graze their horses on the Commons, the scheme of management does not allow the exercising or breaking of horses. The Group have been encouraged to apply for a modification to the Definitive Map for a bridle path in this area.

Commoners are waiting to see what South Gloucestershire Council are going to do.

Is this a footpath or bridleway?

The woodland has been cut back by people – it is not supposed to be used by horses, now it has been cleared-could be considered as trespassing?

The Commons is owned by Sir John Jenkinson and managed by South Gloucestershire Council.

Cllr Hope-meeting being held on the 19th September regarding the Scrub Management- dangerous weeds on the Common. Residents are not supposed to the grass outside their own property – at times it can be cut back too much

Bus Stop – Chipping Sodbury

Cllr Musty-commented on the money being spent moving a bus stop on Chipping Sodbury, High Street. The existing bus stop is being moved because vans/cars park in front preventing passengers seeing on coming bus numbers and disabled people and mothers/carers with pushchairs have difficulty getting on the bus.
